## **1. Boarding Terms**

## **2. Services Provided**

- Fresh water, clean bedding, and daily stall cleaning
- Turnout in safely fenced paddocks or stalls with shelter
- Blanketing/fly gear application as needed
- Basic wellness checks

- Once-daily owner updates upon request

Any additional services (medication, farrier/vet holding, wound care, etc.) must be pre-arranged and may incur additional fees.

### **3. Horse Health Requirements**

Owner affirms that the horse is in good health and provides:

- Proof of current vaccinations: EWT, WNV, Flu/Rhino, Rabies, Strangles
- Negative Coggins within the past 12 months
- Signed Equine Emergency Contact Sheet

The barn reserves the right to refuse board if health documentation is incomplete or the horse shows signs of illness or dangerous behavior.

### **4. Emergency Care**

In case of illness or injury, [Business Name] will make reasonable efforts to contact the owner. If the owner cannot be reached, the barn has permission to secure veterinary care at the owner's expense.
